In consideration of being permitted upon the property of Releasee located at 7601 Old Railroad Bed Road Maryville, Blount County, TN 37801, herein referred to as "Property", where Releasor may be exposed to firearms activities and other club sponsored activities, and to areas which are otherwise acknowledged to pose a risk of injury to person or property, the Releasor, for himself, their spouse, legal representatives, personal representatives, estate, heirs, assigns and beneficiaries (hereinafter collectively referred to as the ("Releasor")) hereby releases, waives and discharges to Releasee, its agents, employees, officers and directors (hereinafter collectively referred to as the ("Releasee")) from all liability to the Releasor, for any and all loss of damage, and any claim for damages resulting there from, on account of injury to Releasor's person or property, even injuries resulting in death of Releasor in or upon the Property of Releasee.

Releasor agrees to indemnify the Releasee and each of them, from any loss, liability, damage or cost that may incur due to the presence of Releasor is in or upon the Property of Releasee.

Releasor hereby assumes full responsibility for the risk of personal injury, death or property damage due to any conditions of the Property of Releasee or due to the negligence of Releasee or otherwise while Releasor is in or upon the Property of Releasee.

Releasor expressly agrees that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that if any portion thereof is held invalid, the remainder shall, notwithstanding, continue in full legal force and effect.

## **Safety Rules**

**Absolutely no alcohol allowed on the course or prior to shooting.**

**Do not load gun until you are in the shooting station with the gun over the firing rail and pointed down range.**

**Only two rounds are to be loaded in your gun when preparing to shoot.**

**Absolutely no backup shooting, only the shooter in the station is allowed to fire at targets.**

**Keep gun when loaded, over the gun rail and pointed down range when in the station.**

**If you should break two targets with one shot, make sure you eject the second round before leaving the station.**

**If your gun should jam, keep it pointed down range and over the gun rail and contact the range manager for assistance.**

**At all times on this property: all pumps and automatics must have the gun breach open and all double barrels broke open so everyone can see the gun is not loaded, except in the station with the gun barrel pointed down range and over the firing rail.**

**Anyone under 16 years of age must be accompanied by an adult.**

**You must have a valid driver's license and be at least 16 years of age to operate a Club Cart or any other vehicle on the property. When using our carts, they are for transport only, NOT for your pleasure (I. E. racing, etc...) If you damage a cart, you will be financially responsible for the repairs.**

**Eye and hearing protection must be worn while shooting.**

**If you have a misfire, stay in the station with the gun pointed down range, check for and remove wad from barrel. Orange sticks are in each station to help you with this.**

**Anyone not following these safety rules will be ejected from club property.**

**Please be courteous and respectful to fellow shooters and staff.**

**You can only use 2 ¾ inch, 7 ½, 8 or 9 lead shot size. To use anything else is a safety hazard.**
